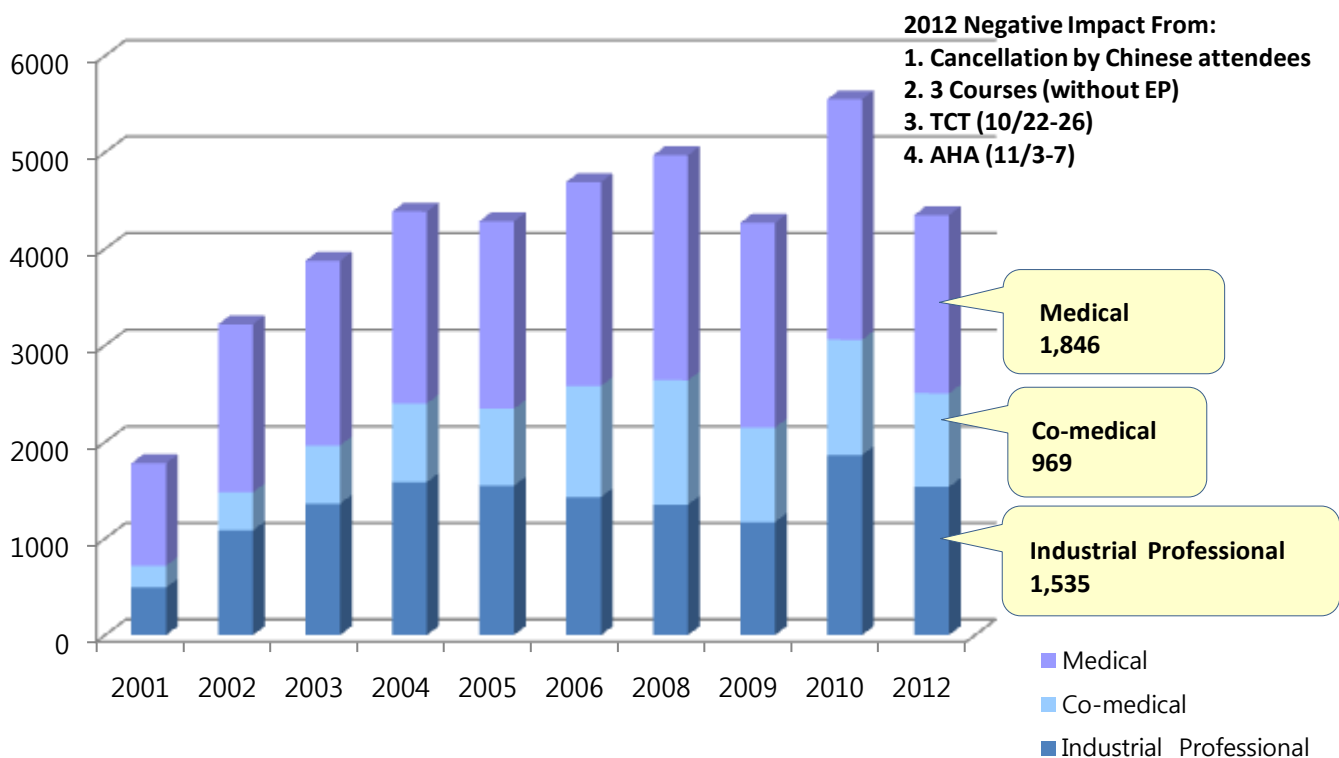
Outline of CCT 2013 Live Course

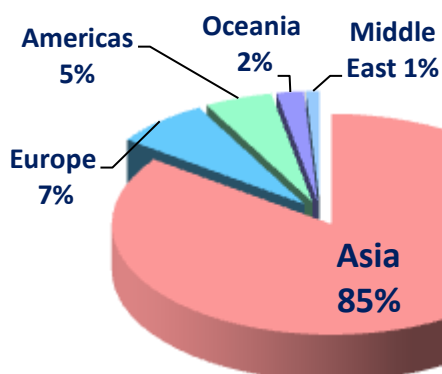

CCT2012 Attendee Demographics

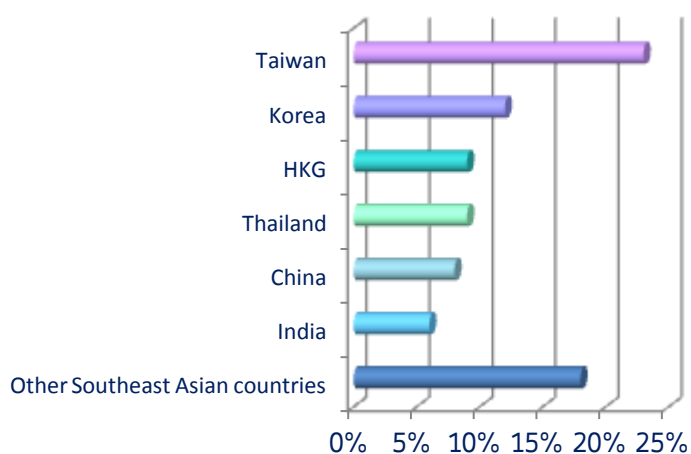
CCT Participants in 2012

CCT 2013 Exhibitor Guidelines

1. Items to be exhibited:

Products related to cardiovascular surgery as well as intervention medical treatment such as equipment, devices, medicine, books, etc.

2. Exhibition fee:

(Size if one booth is about 3.0m W x 2.0m D x 2.5m H)

*Coronary: Kobe International Exhibition Hall No.1

A Zone : Six booths or more **577,500 JPY**/per booth

B Zone : Six booths or more **472,500 JPY**/per booth

C Zone : Up to six booths **420,000 JPY**/per booth

*Peripheral: Kobe International Exhibition Hall No.3

315,000 JPY/per booth

* The booth allocation will be determined by the organizer based upon sizes and number of booths.

4. Application deadline: **Friday, April 26, 2013**

Please note that applications will be accepted on a first-come, first-served basis.

5. Payment:

The payment of exhibition booth must be made by wire transfer by the due date mentioned in the invoice.

All fee associated with the wire transfer are the responsibility of the exhibitor.

6. Cancellation policy:

Please noted that once the application has been completed, cancellation is not accepted unless the organizer approves to do so. In that case, the following cancellation fee will be charged based on the date.

From June 1, 2013 to July 14, 2013 . . . 50%

After July 15, 2013 80%

After September 15, 2013 100%

7. Basic booth specifications:

Booths are uniformly dimensioned, consisting of system panels for rear and side walls. When two or more booths are used to form a continuous exhibition space, side partitions from neighboring booths will not be provided.

8. Electric supply:

Please note the basic booth does not include electric supply. If you are planning to use electrical equipment, please submit Optional Form.

9. Exhibition date and opening time:

Thursday, October 17, 2013: 9:00-18:00

Friday, October 18, 2013: 9:00-18:00

Saturday, October 19, 2013: 9:00-17:00

10. Move-in and move-out:

Move-in: Wednesday, October 16, 2013: All day

Move-out: Saturday, October 19, 2013: After 17:00

(Specific time of move-in and move-out will be announced in the middle of August.)

11. Exhibitors Manual:

Exhibitor Manual will be sent for further details in July.

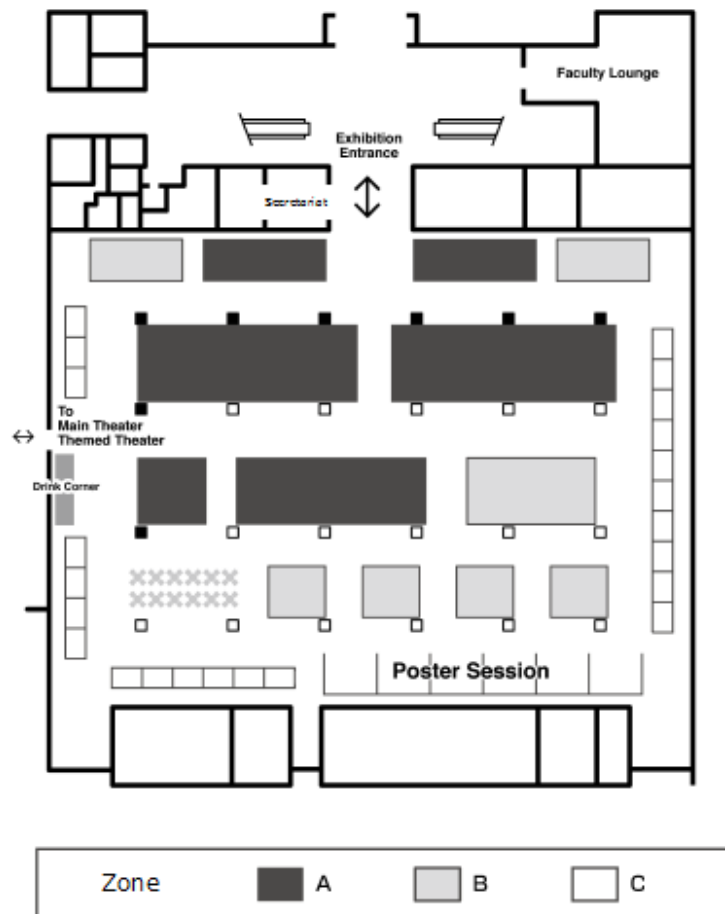
12. Exemption from responsibility:

The exhibition may be postponed or cancelled due to inevitable circumstances.

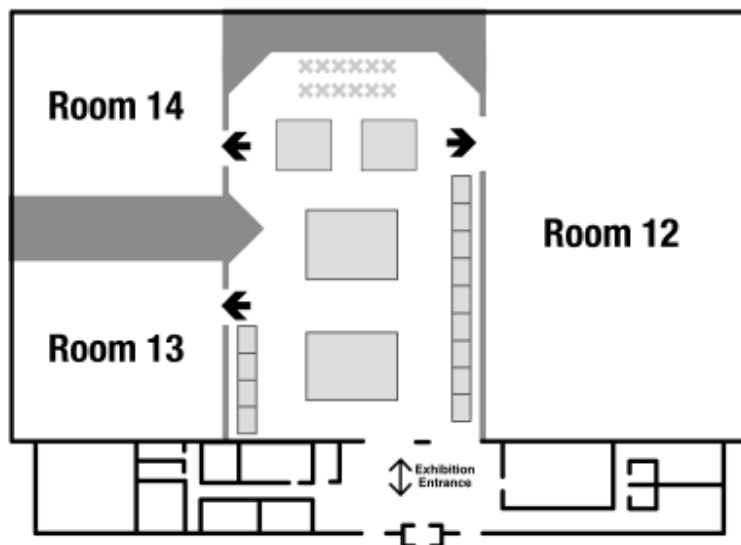

Exhibition Hall Map

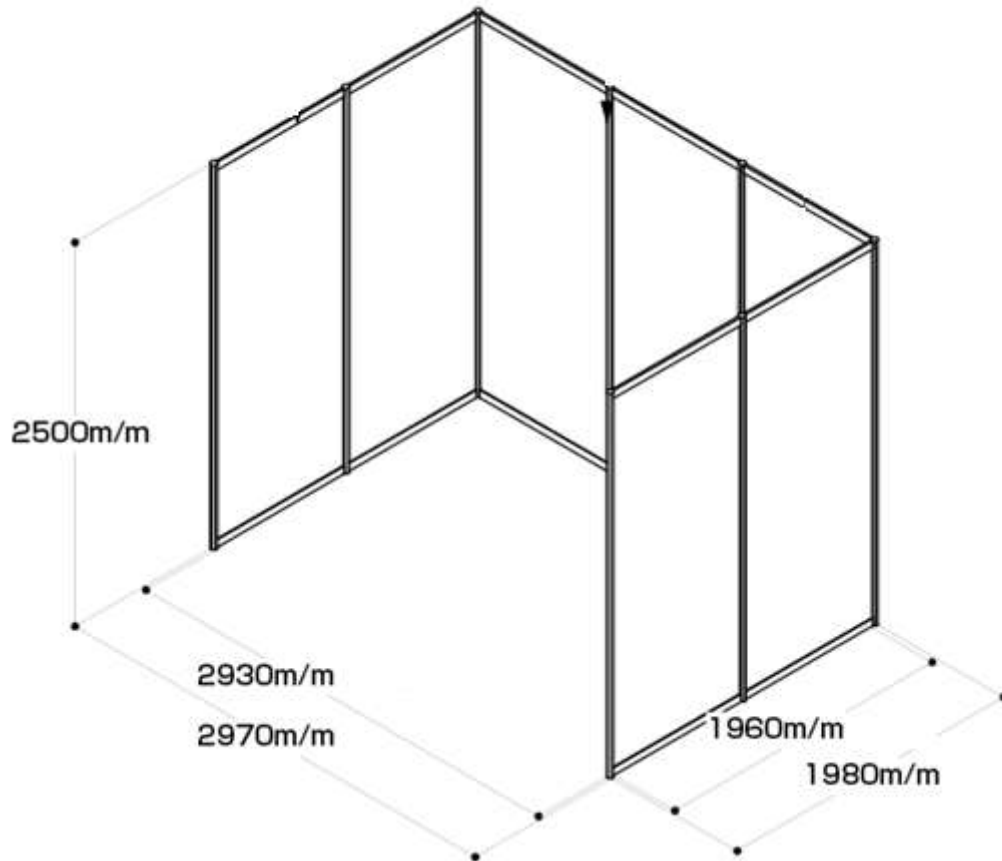
- **Coronary: Hall 1 1F**
